DECLARATION

OF COVENANTS, CONDITIONS AND RESTRICTIONS

THIS DECLARATION, made on the date hereinafter set forth by WILDWOOD VILLAS, INC., hereinafter referred to as "Declarant;"

WITNESSETH:

WHEREAS, Declarant is the owner of certain property in the City of Greenville, Greenville Township, Pitt County, North Carolina, which is more particularly described as follows:

That certain lot or parcel of land situated in the City of Greenville, Greenville Township, Pitt County North Carolina and more particularly described as follows: BEGINNING at a railroad spike located as follows: BEGINNING at the intersection of the center lines of Third Street and Beech Street, said point being marked by a railroad spike and thence, following the center line of Beech Street North 24-46-29 East 135.71 feet to a railroad spike which is the property line of James Brown, Jr., et al, it being a corner between James Brown, Jr., et al, and the property of Bernice Branch and continuing with the division line between the said Brown and Williams land, which is an extension of the center line of Beech Street North 24-46-29 East 290 feet to an iron stake which is the point of BEGINNING for the property described herein; thence from said point of BEGINNING, following the eastern property line of the said James Brown, Jr., et al, North 24-46-29 East 227.47 feet to a point in the said eastern property line of James Brown, Jr., et al; thence South 68-54-34 East 236.44 feet to an iron stake; thence South 21-05-26 West 154.00 feet to an iron stake; thence North 68-54-34 West 2.51 feet to an iron stake; thence South 21-05-26 West 73.00 feet to an iron stake; the stake 20 fe feet to an iron stake in the J. N. Williams Heirs line; thence with the J. N. Williams Heirs line North 68-54-34 West 248.55 feet to the point of BEGINNING. The property The property described herein being part of Lot No. 1 of the Jas. Brown Subdivision as shown on the map recorded in Map Book 2, at Page 62, Pitt County Registry.

The property hereinbefore described is subject to an easement held by the City of Greenville which is recorded in Book X-31, Page 746, Pitt County Registry, said easement being shown by the said Map hereinbefore referred to.

THERE IS ALSO CONVEYED an easement along the western boundary of the property of Jesse N. Williams, Jr., et al as described in that certain deed dated July 16, 1977, and recorded in Book A-46, Page 773, Pitt County Registry, adjacent to the James Brown, Jr., et al, property, said easement being sixty feet wide and adjacent to and at right angles to said Brown line and extends between the BEGINNING point of the foregoing description and the termination of northern end of Beech Street. The easement is for the benefit of the J. N. Williams Heirs, their heirs and assigns, and the Grantors herein, their heirs and assigns.

NOW, THEREFORE, Declarant hereby declares that all of the properties described above shall be held, sold and conveyed subject to the following easements, restrictions, covenants and conditions, which are for the purpose of protecting the value and desirability of, and which shall run with, the real property and be binding on all parties having any right, title or interest in the described properties or any part thereof, their heirs, successors and assigns, and shall inure to the benefit of each owner thereof.

ARTICLE I

DEFINITIONS

Section 1: "Association" shall mean and refer to WILDWOOD VILLAS HOMEOWNERS ASSOCIATION, its successors and assigns.

Section 2: "Owner" shall mean and refer to the record owner, whether one or more persons or entities, of a fee simple title to any Lot which is a part of the Properties, including contract sellers, but excluding those having such interest merely as security for the performance of an obligation.

Section 3: "Properties" shall mean and refer to that certain real property hereinbefore described, and such additions thereto as may hereafter be brought within the jurisdiction of the Association.

Section 4: "Common Area" shall mean all real property (including improvements thereto) owned by the Association for the common use and enjoyment of the owners. The common area to be reserved to the Association at the time of the conveyance of the first lot is described as follows:

That certain lot or parcel of land situated in the City of Greenville, Greenville Township, Pitt County North Carolina and more particularly described as follows: BEGINNING at a railroad spike located as follows: BEGINNING at the intersection of the center lines of Third Street and Beech Street, said point being marked by a railroad spike and thence, following the center line of Beech Street North 24-46-29 East 135.71 feet to a railroad spike which is the property line of James Brown, Jr., et al, it being a corner between James Brown, Jr. et al, and the property of Bernice Branch and continuing with the division line between the said Brown and Williams land, which is an extension of the center line of Beech Street North 24-46-29 East 290 feet to an iron stake which is the point of BEGINNING for the property described herein; thence from said point of BEGINNING, following the eastern property line of the said James Brown, Jr., et al, North 24-46-29 East 227.47 feet to a point in the said eastern property line of James Brown, Jr., et al; thence South 68-54-34 East 236.44 feet to an iron stake; thence South 21-05-26 West 154.00 feet to an iron stake; thence North 68-54-34 West 2.51 feet to an iron stake; thence South 21-05-26 West 73.00 feet to an iron stake in the J. N. Williams Heirs line; thence with the J. N. Williams Heirs line North 68-54-34 West 248.55 feet to the point of BEGINNING. The property described herein being part of Lot No. 1 of the Jas. Brown Subdivision as shown on the map recorded in Map Book 2, at Page 62, Pitt County Registry.

The property hereinbefore described is subject to an easement held by the City of Greenville which is recorded in Book X-31, Page 746, Pitt County Registry, said easement being shown by the said Map hereinbefore referred to.

THERE IS ALSO CONVEYED an easement along the western boundary of the property of Jesse N. Williams, Jr., et al as described in that certain deed dated July 16, 1977, and recorded in Book A-46, Page 773, Pitt County Registry, adjacent to the James Brown, Jr., et al, property, said easement being sixty feet wide and adjacent to and at right angles to said Brown line and extends between the BFGINNING point of the foregoing description and the termination of northern end of Beech Street. The easement is for the benefit of the J. N. Williams Heirs, their heirs and assigns, and the Grantors herein, their heirs and assigns.

THERE IS EXCEPTED FROM THE FOREGOING the unit ownership area shown on map hereinafter referred to as Lots 1 (one) through 16 (sixteen) inclusive.

ALSO EXCEPTED is all of Beech Street as shown on the aforesaid map, said Street having a width of 60 feet.

All of the foregoing excepted portions are accurately shown on map by Triangle Engineering & Surveying, Inc. dated December 27, 1979, entitled, "Wildwood Villas, Section I," reference to which is hereby directed for a more accurate description of same.

Section 5: "Lot" shall mean and refer to any plot of land shown upon any recorded subdivision map of the properties with the exception of the Common Area.

Section 6: "Declarant" shall mean and refer to WILDWOOD VILLAS, INC., its successors and assigns, if such successors or assigns should acquire more than one undeveloped lot from the Declarant for the purpose of development.

Section 7: "Member" shall mean and refer to every person or entity who holds membership in the Association.

ARTICLE II

PROPERTY RIGHTS

Section 1: Owner's Easements of Enjoyment. Every owner shall have a right and easement of enjoyment in and to the Common Area which shall be appurtenant to and shall pass with the title to every Lot, subject to the following provisions:

- (a) the right of the Association to charge reasonable admission and other fees for the use of any recreational facility situated upon the Common Area;
- (b) the right of the Association to charge reasonable admission and other fees for the use of any recreational facility situated upon the Common Area;
- (b) the right of the Association to suspend the voting rights and right to use of the recreational facilities by an owner for any period during which any assessment against his lot remains unpaid; and for a period not to exceed sixty (60) days for any infraction of its published rules and regulations;

- (c) the right of the Association to dedicate or transfer all or any part of the Common Area to any public agency, authority utility for such purposes and subject to such conditions as may be agreed to by the members. No such dedication or transfer shall be effective unless an instrument agreeing to such dedication or transfer signed by two-thirds of each class of members has been recorded.
- (d) the right of individual owners to the exclusive use of parking spaces as provided in this article.

Section 2: Delegation of Use. Any owner may delegate, in accordance with the Bylaws, his right of enjoyment to the Common Area and facilities to the members of his family, his tenants, or contract purchasers who reside on the property.

Section 3: Parking Rights. Ownership of each lot shall entitle the owner or owners thereof to the use of not more than two automobile parking spaces, which shall be as near and convenient to said lot as reasonably possible, together with the right of ingress and egress in and upon said parking area. The Association shall permanently assign two vehicle parking spaces for each dwelling.

ARTICLE III

MEMBERSHIP AND VOTING RIGHTS

Section 1: Every owner of a lot which is subject to assessment shall be a member of the Association. Membership shall be appurtenant to and may not be separated from ownership of any lot which is subject to assessment.

Section 2: The Association shall have two classes of voting membership.

Class A. Class A membership shall be all owners, with the exception of the Declarant, and shall be entitled to one vote for such lot owned. When more than one person holds an interest in any lot, all such persons shall be members. The vote

for such lot shall be exercised as then determined, but in no event shall more than one vote be cast with respect to any lot.

Class B. The Class B member(s) shall be the Declarant and shall be entitled to three (3) votes for each lot owned, and notwithstanding any other provisions herein, shall be assessed at a rate of not more than twenty-five percent (25%) of the Class A membership rate. Class B membership shall cease, if not sooner terminated as provided herein on January 1, 1985.

ARTICLE IV

COVENANT FOR MAINTENANCE ASSESSMENTS

Section 1: Creation of the Lien and Personal Obligation of Assessments. The Declarant, for each lot owned within the properties, hereby covenants, and each owner of any lot by acceptance of a deed therefor, whether or not it shall be so expressed in such deed, is deemed to covenant and agree to pay to the Association: (1) annual assessments or charges, and (2) special assessments for capital improvements, such assessments to be established and collected as hereinafter provided. The annual and special assessments, together with interest, costs, and reasonable attorney's fees, shall be a charge on the land and shall be a continuing lien upon the property against which each such assessment is made. Each such assessment, together with interest, costs, and reasonable attorney's fees, shall also be the personal obligation of the person who was the owner of such property at the time when the assessment fell due. The personal obligation for delinquent assessment shall not pass to his successors in title unless expressly assumed by them.

Section 2: Purpose of Assessments. The assessments levied by the Association shall be used exclusively to promote the recreation, health, safety and welfare of the residents of

the Properties and in particular for the acquisition, improvement and maintenance of properties, services and facilities devoted to this purpose and related to the exterior maintenance of homes situated upon Townhouse Lots or for the use and enjoyment of the Common Area, including but not limited to, the cost of repairs, replacements and additions, the cost of labor, equipment, materials, management and supervision, the payment of taxes assessed against the Common Area, the procurement and maintenance of insurance in accordance with the Bylaws, the payment of charges for common television antenna service to Townhouse Lots, the employment of attorneys to represent the Association when necessary, and such other needs as may arise.

Section 3: Basis and Maximum of Annual Assessments.

Until January 1 of the year immediately following the conveyance of the first lot to an Owner, the maximum annual assessment shall not exceed \$25.00 per lot, per owner, per month, prorated for the remainder of said year.

- (a) From and after January 1 of the year immediately following the conveyance of the first lot to an Owner, the maximum annual assessment may be increased effective January 1 of each year without a vote of the membership in conformance with the rise, if any, of the Consumer Price Index (published by the Department of Labor, Washington, D.C.) from the preceding month of July.
- (b) From and after January 1 of the year immediately following the conveyance of the first lot of an Owner, the maximum annual assessment for the next succeeding two (2) years may be increased above that established by the Consumer Price Index formula by a vote of the members, and for each succeeding period of two (2) years thereafter, provided that any such change shall have the assent of two-thirds of the votes of each class of members who are voting in person or by proxy, at a

meeting duly called for this purpose, written notice of which shall be sent to all members not less than thirty (30) days nor more than sixty (60) days in advance of the meeting setting forth the purpose of the meeting. The limitations hereof shall not apply to any change in the maximum and basis of the assessments undertaken as an incident to a merger of consolidation in which the Association is authorized to participate under its Articles of Incorporation.

(c) The Board of Directors may fix the annual assessment at an amount not in excess of the maximum.

Section 4: Special Assessments for Capital Improvements. In addition to the annual assessments authorized above, the Association may levy, in any assessment year, a special assessment applicable to that year for the purpose of defraying, in whole or in part, the cost of any construction, reconstruction, repair or replacement of a capital improvement upon the Common Area, including fixtures and personal property related thereto, provided that any such assessment shall have the assent of two-thirds of the votes of each class of members who are voting in person or by proxy at the meeting duly called for this purpose.

Section 5: Notice and Quorum for Any Action Authorized Under Sections 3 and 4. Written notice of any meeting called for the purpose of taking any action authorized under Sections 3 or 4 shall be sent to all members not less than thirty (30). days nor more than sixty (60) days in advance of the meeting. At the first such meeting called, the presence of members or of proxies entitled to cast sixty (60) per cent of all the votes of each class of membership shall constitute a quorum. If the required quorum is not present, another meeting may be called subject to the same notice requirements, and the required quorum at the subsequent meeting shall be one-half of the required

quorum at the preceding meeting. No such subsequent meeting shall be held more than sixty (60) days following the preceding meeting.

Section 6: Uniform Rate of Assessment. Except as provided for Class B members, both annual and special assessments must be fixed at a uniform rate for all lots and may be collected on a monthly basis.

Section 7: Date of Commencement of Annual Assessments. Due Dates. The annual assessments provided for herein shall commence as to all lots on the first day of the month following the conveyance of the Common Area. The first annual assessment shall be adjusted according to the number of months remaining in the calendar year. The Board of Directors shall fix the amount of the annual assessments against each lot at least thirty (30) days in advance of each annual assessment period. Written notice of the annual assessment shall be sent to every Owner subject thereto. The due dates shall be established by the Board of Directors. The Association shall, upon demand, and for a reasonable charge, furnish a certificate signed by an officer of the Association setting forth whether the assessments on a specified lot have been paid. A properly executed certificate of the Association as to the status of assessments on a lot is binding upon the Association as of the date of its issuance.

Section 8: Effect of Nonpayment of Assessment.

Remedies of the Association. Any assessment not paid within thirty (30) days after the due date shall bear interest from the due date at the rate of six (6) per cent per annum. The Association may bring an action at law against the Owner personally obligated to pay the same, or foreclose the lien against the property. No owner may waive or otherwise escape or deny liability for the assessments provided for herein by non-use of the Common Area or abandonment of his lot.

Section 9: Subordination of the Lien to Mortgages. The lien of the assessments provided for herein shall be subordinate to the lien of any first mortgage. Sale or transfer of any lot shall not affect the assessment lien. However, the sale or transfer of any lot pursuant to mortgage foreclosure or any proceeding in lieu thereof, shall extinguish the lien of such assessments as to payments which became due prior to such sale or transfer. No sale or transfer shall relieve such lot from liability for any assessments thereafter becoming due or from the lien thereof.

Section 10: Exempt Property. All property dedicated to and accepted by, a local public authority and all properties owned by a charitable or non-profit organization exempt from taxation by the laws of the State of North Carolina, shall be exempt from the assessments created herein. However, no land or improvements devoted to dwelling use shall be exempt from said assessments.

ARTICLE V

PARTY WALLS

Section 1: General Rules of Law to Apply. Each wall which is built as a part of the original construction of the homes upon the Properties and placed on the dividing line between the lots shall constitute a party wall, and, to the extent not inconsistent with the provisions of this Article, the general rules of law regarding party walls and liability for property damage due to negligence or willful acts or omissions shall apply thereto.

Section 2: Sharing of Repair and Maintenance. The cost of reasonable repair and maintenance of a party wall shall be shared by the Owners who make use of the wall in proportion to such use.

Section 3: Destruction by Fire or Other Casualty. If a party wall is destroyed or damaged by fire or other casualty, any Owner who has used the wall may restore it and if the other Owners thereafter make use of the wall, they shall contribute to the cost of restoration thereof in proportion to such use without prejudice, however, to the right of any such Owners to call for a larger contribution from the others under any rule of law regarding liability for negligent or willful acts or omissions.

Section 4: Weatherproofing. Notwithstanding any other provisions of this Article, an Owner who by his negligent or willful act causes the party wall to be exposed to the elements shall bear the whole cost of furnishing the necessary protection against such elements.

Section 5: Right to Contribution Runs with Land.

The right of any Owner to contribution from any other Owner under this Article shall be appurtenant to the land and shall pass to such Owner's successors in title.

Section 6: Arbitration. In the event of any dispute arising concerning a party wall, or under the provisions of this Article, each party shall choose one arbitrator, and such arbitrators shall choose one additional arbitrator and the decision shall be made by a majority of all the arbitrators, and binding on the parties.

ARTICLE VI

EXTERIOR MAINTENANCE

Section 1: Types of Maintenance. In addition to maintenance upon the Common Area, the Association shall provide exterior maintenance upon each Townhouse lot which is subject to assessment hereunder, as follows: paint, repair, replace and care of roofs, gutters, downspouts, exterior building surfaces, trees, shrubs, walks, and other exterior improvements. Such

exterior maintenance shall not include glass surfaces. In order to enable the Association to accomplish the foregoing, there is hereby reserved to the Association the right to unobstructed access over and upon each lot at all reasonable times to perform maintenance as provided in this Article.

Section 2: Costs Subject to Assessments. In the event that the need for maintenance, repair, or replacement is caused through the willful or negligent act of the Owner, his family, guests, or invitees, or tenants, or is caused by fire, lightening, windstorm, hail, explosion, riot, riot attending a strike, civil commotion, aircrafts, vehicles and smoke, as the foregoing are defined and explained in North Carolina Standard Fire and Extended Coverage insurance policies, the cost of such maintenance, replacement or repairs shall be added to and become part of the assessment to which such lot is subject.

ARTICLE VII

ARCHITECTURAL CONTROL

No building, fence, wall or other structure shall be commenced, erected or maintained upon the Properties, nor shall any exterior addition to or change or alteration therein be made until the plans and specifications showing the nature, kind, shape, height, materials and location of the same shall have been submitted to and approved in writing as to harmony of external design and location in relation to surrounding structures and topography by the Board of Directors of the Association, or by an architectural committee composed of three (3) or more representatives appointed by the Board. In the event said Board, or its designated committee, fails to approve or disapprove such design and location within thirty (30) days after said plans and specificiations have been submitted to it, approval will not be

required and this Article will be deemed to have been fully complied with. For the purpose of this Article, storm windows and a storm door on the rear entrance may be placed and maintained on townhouses without need for approval of the architectural committee; but a storm door placed and maintained at the entrance, or front door, to a townhouse must be approved by the architectural committee in accordance with the provisions of this Article.

ARTICLE VIII

USE RESTRICTIONS

Section 1: Land Use and Building Type. No lot shall be used except for residential purposes.

Section 2. <u>Nuisance</u>. No noxious or offensive activity shall be conducted upon any lot nor shall anything be done thereon which may be or may become an annoyance or nuisance to the neighborhood.

Section 3: Animals. No animals, livestock or poultry of any kind shall be kept or maintained on any lot or in any dwelling except that dogs, cats or other household pets may be kept or maintained provided that they are not kept or maintained for commercial purposes.

Section 4: Outside Antennae. No outside radio or television antennae shall be erected on any Townhouse unless and until permission for the same has been granted by the Board of Directors of the Association or its architectural control committee.

ARTICLE IX

EASEMENTS

Easements for installation and maintenance of utilities and drainage facilities are reserved as shown on the recorded plat. Within these easements no structure, planting or other material shall be placed or permitted to remain which may interfere with the installation and maintenance of utilities, or which may change the direction of flow of drainage channels in the easements, or which may obstruct or retard the flow of water through drainage channels in the easements.

All lots and Common Areas shall be subject to easements for the encroachment of initial improvements constructed on adjacent lots by the Declarant to the extent that such initial improvements actually encroach, including, but not limited to, such items as overhanging eaves, stoops, chimneys, bay windows, gutter and downspouts, misaligned common walls, foundation footings and walls. Declarant shall have a reasonable construction easement across the Common Area for the purpose of construction improvements on the lots.

ARTICLE X

GENERAL PROVISIONS

Section 1: Enforcement. The Association, or any Owner, shall have the right to enforce, by any proceeding at law or in equity, all restrictions, conditions, covenants, reservations, liens and charges now or hereafter imposed by the provisions of this Declaration. Failure by the Association or by any Owner to enforce any covenant or restrictions herein contained shall in no event be deemed a waiver of the right to do so thereafter.

Section 2: Severability. Invalidation of any one of these covenants or restrictions by judgment or court order shall in no wise affect any other provisions which shall remain in full force and effect.

Section 3: Amendment. The covenants and restrictions of this Declaration shall run with and bind the land, for a term of twenty (20) years from the date this Declaration is recorded, after which time they shall be automatically extended for successive periods of ten (10) years. This Declaration may be amended during the first twenty (20) year period by an instrument signed by not less than ninety (90) per cent of the lot Owners, and thereafter by an instrument signed by not less than seventy-five (75) per cent of the lot Owners. Any amendment must be recorded.

Section 4. Annexation. Except as provided in Section 5(b) of this Article, additional residential property and Common Area may be annexed to the Properties with the consent of two-thirds of each class members.

Section 5: FHA/VA Approval.

- (a) As long as there is a Class B membership, the following actions will require the prior approval of the Federal Housing Administration of the Veterans Administration: annexation of additional properties, dedication of Common Area, and amendment of this Declaration of Covenants, Conditions and Restrictions.
- (b) Additional land within the area described in Deed Book N-46, Page 26 and Deed Book G-48, Page 693 of the land records of Pitt County, North Carolina, may be annexed by the Declarant without the consent of members within ten (10) years of the date of this instrument.
